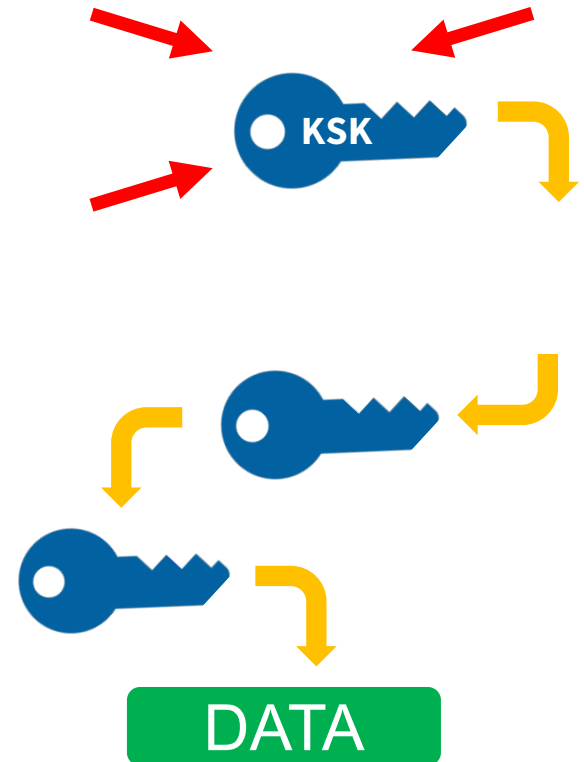

Organization Operations and Finances

- ⦿ Focused on long-term financial planning
 - Currently planning for FY19 and FY20 together – for public comment in January
- ⦿ **FY18 Q1 financial position:**
 - Spent \$6m less than budgeted, with \$1m less in funding
 - Net effect of \$5m under budget

Policy Update: Supporting Organizations (SOs)



ccNSO

The ccNSO (Council and members) works on global policies relating to country code top-level domain name (ccTLD) policies (e.g., .br, .uk).

GNSO

The GNSO Council is composed of 21 members — divided into 2 houses (contracted and non-contracted parties) — who work on generic top-level domain name (gTLD) policies (e.g., .com, new gTLDs).

ASO

The ASO Address Council is composed of 15 volunteers — 3 from each of the Regional Internet Registries (RIRs)— who work on global Internet Protocol (IP) Address Policy.

Second Eastern European DNS Forum - Minsk

- [The 2nd Eastern European DNS Forum](#) took place in Minsk, Belarus from 12-13 October 2017
- Over 160 participants from 5 different countries
- Topics included technical engagement and security issues (based on community interest and demand in the region)
- Strong participation from ICANN org including Board IETF liaison **Jonne Soininen**
- Day 1 focused on tech-tutorials and presentations mixing a range of topics both suggested by the community and organizers
- Day 2 focused on policy panel discussions



ICANN60: GAC Capacity Building Workshop




- ⦿ Parallel event to ICANN60
- ⦿ It was our fourth Governmental Advisory Committee (GAC) capacity building workshop, after the success of the events in Kenya and Fiji
- ⦿ The workshop targeted Middle East GAC representatives, and was open for anyone to attend

Policy Update

Generic Names Supporting Org. (GNSO)

New Areas of Work in FY18 Q1

- Approval of Data Collection Request from the review of all rights protection mechanisms (RPM) Policy Development Process Working Group
- Initiation of new gTLD Subsequent Procedures Policy Development Process Work Track 5, which will focus on Geo Names
- Selection process for GNSO liaison to the Governmental Advisory Committee

Completed Work in FY18 Q1

- Nomination of GNSO Candidates for the Third Review of ICANN Accountability and Transparency (ATRT3)
- GNSO Adoption of the Final Report of the Cross-Community Working Group Framework for the Use of Country and Territory names as TLDs
- Withdrawal as a Chartering Organization from the Internet Governance Cross-Community Working CCWG-IG and request for a proposal for a new structure for GNSO Council consideration by ICANN61
- Confirmation of GNSO Representative to the Empowered Community Administration
- Approval of the fundamental Bylaw amendment to transfer responsibility for reconsideration requests to a new Board Accountability Mechanisms Committee

Country-Code Names Supporting Org. (ccNSO)

New areas of work in FY18 Q1

- ⦿ Country-code Policy Development Process 3 Working group on retirement of ccTLDs well underway
- ⦿ ccNSO Guideline Review Committee focus on ccNSO as Decisional Participant: defining the ccNSO internal procedures
- ⦿ Restructuring of the ccNSO Strategic and Operational Planning Working Group to standing committee
- ⦿ Participation for the first time in GNSO Policy Development Process (subsequent procedures work track 5 on geographic names)
- ⦿ Launch of ICANN Board seat 12 nomination process and ccNSO Council Elections

⦿ Completed work in FY18 Q1

- ⦿ Completion and closure of Cross-Community Working Group (CCWG) (with the GNSO) on use of country and territory names as Top Level Domains
- ⦿ Completion of joint Country-Code Names Supporting Org. (ccNSO) / SSAC work on adjusting rules around Fast Track process

Management Update

Office of the Chief Technology Officer (OCTO)

- ⦿ **Emerging identifiers** research
 - A risk analysis of the Digital Object Architecture (DOA) and a technical introduction to blockchain technology was presented at ICANN60

- ⦿ **Identifier Technology Health Initiative (ITHI)** project
 - Metrics for measuring the health of naming identifiers were developed, refined and presented at ICANN60
 - Recursive resolver operators were engaged to obtain personally identifiable information-free data to collect data on these metrics

- ⦿ Continued progress on **Open Data Initiative (ODI)**
 - Initial data census cataloging all internal data sets nearly complete
 - Contractor engaged to add two additional data sets to the pilot by the end of 2017

- ⦿ **Root KSK roll project**
 - The root KSK roll was postponed at least one quarter to gather more information to understand why a larger-than-expected fraction of recursive resolvers performing DNSSEC validation might not be updated with the new KSK

Office of the Chief Technology Officer (OCTO)

- ⦿ **Domain Abuse Activity Reporting (DAAR) project**
 - Presented DAAR at ICANN60
 - Published blog explaining the significance and ubiquity of reputation block listing
 - Revised DAAR methodology white paper

- ⦿ Working closely with EuroPol on digitizing identifier related training materials for online consumption
- ⦿ Continued outreach, training and subject matter expertise related to the security, stability and resiliency of the Internet Identifier systems. Examples include events in Israel, Ukraine, Belarus, Georgia and Mexico

- ⦿ Published Updated **gTLD Marketplace Health Index**
- ⦿ Published draft **Framework for Registry Operators to Respond to Security Threats**
- ⦿ Published report and presented webinar on the “**Statistical Analysis of Domain Name System (DNS) Abuse in gTLDs**”
- ⦿ Launched **Registration Data Access Protocol (RDAP) Pilot Program**
- ⦿ Completed an **Emergency Back-End Registry Operator (EBERO)** simulation confirming each of three ICANN org contracted EBERO providers have successfully completed an EBERO exercise
- ⦿ Launched **Data Protection/Privacy Issues icann.org landing page** to consolidate ICANN GDPR-related activities; published Personal Data “Use” Matrix and gTLD Registration Dataflow Matrix

WHY IT'S IMPORTANT

The New gTLD Program is driving the largest expansion of the Domain Name System ever. Hundreds of new top-level domain names are being introduced into the Internet on a rolling basis.

WHY IT'S IMPORTANT

IDNs at the top-level enable Internet users to access domain names in local languages and scripts.

IDN ccTLDs allow countries and territories to represent their respective names scripts other than US-ASCII characters.

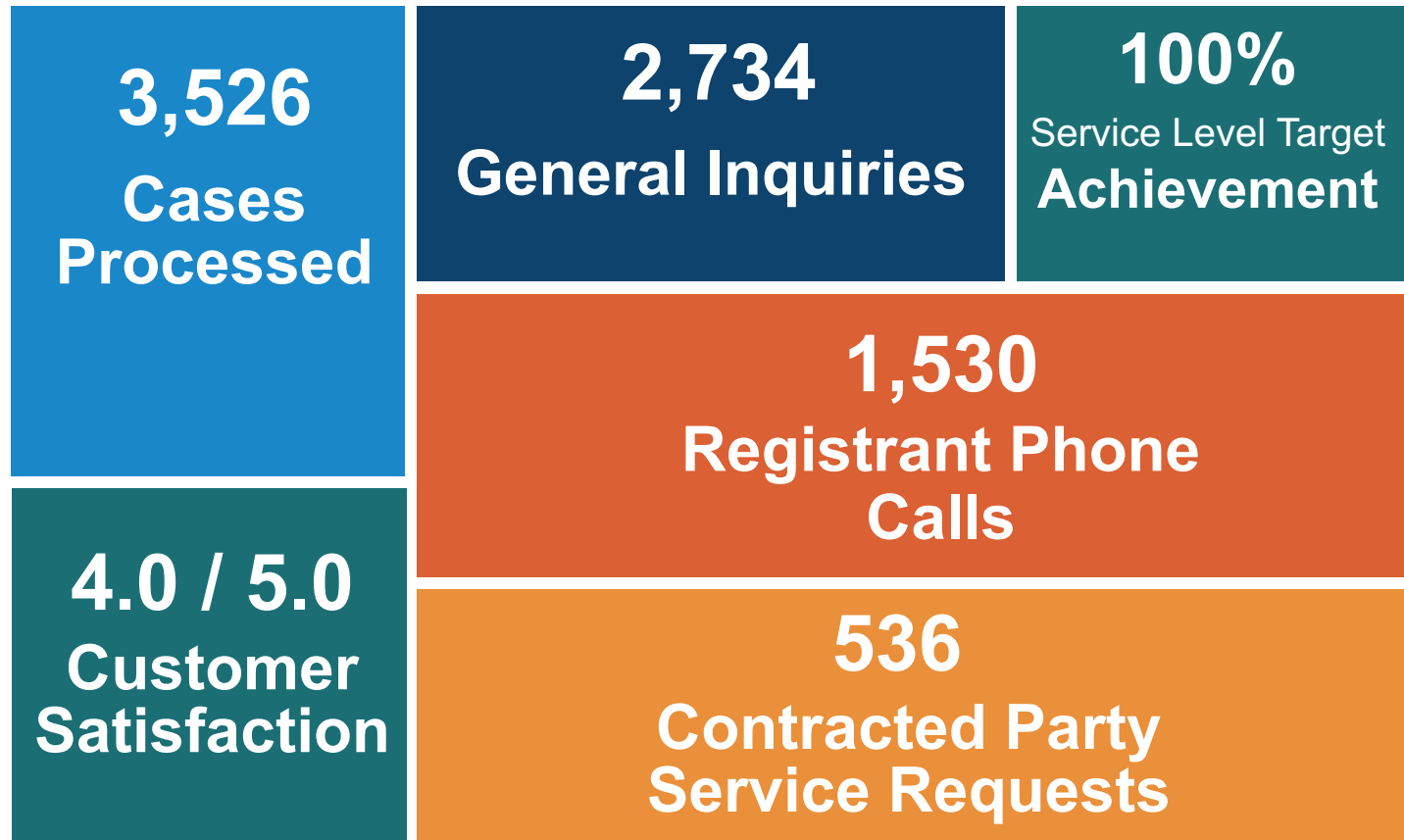

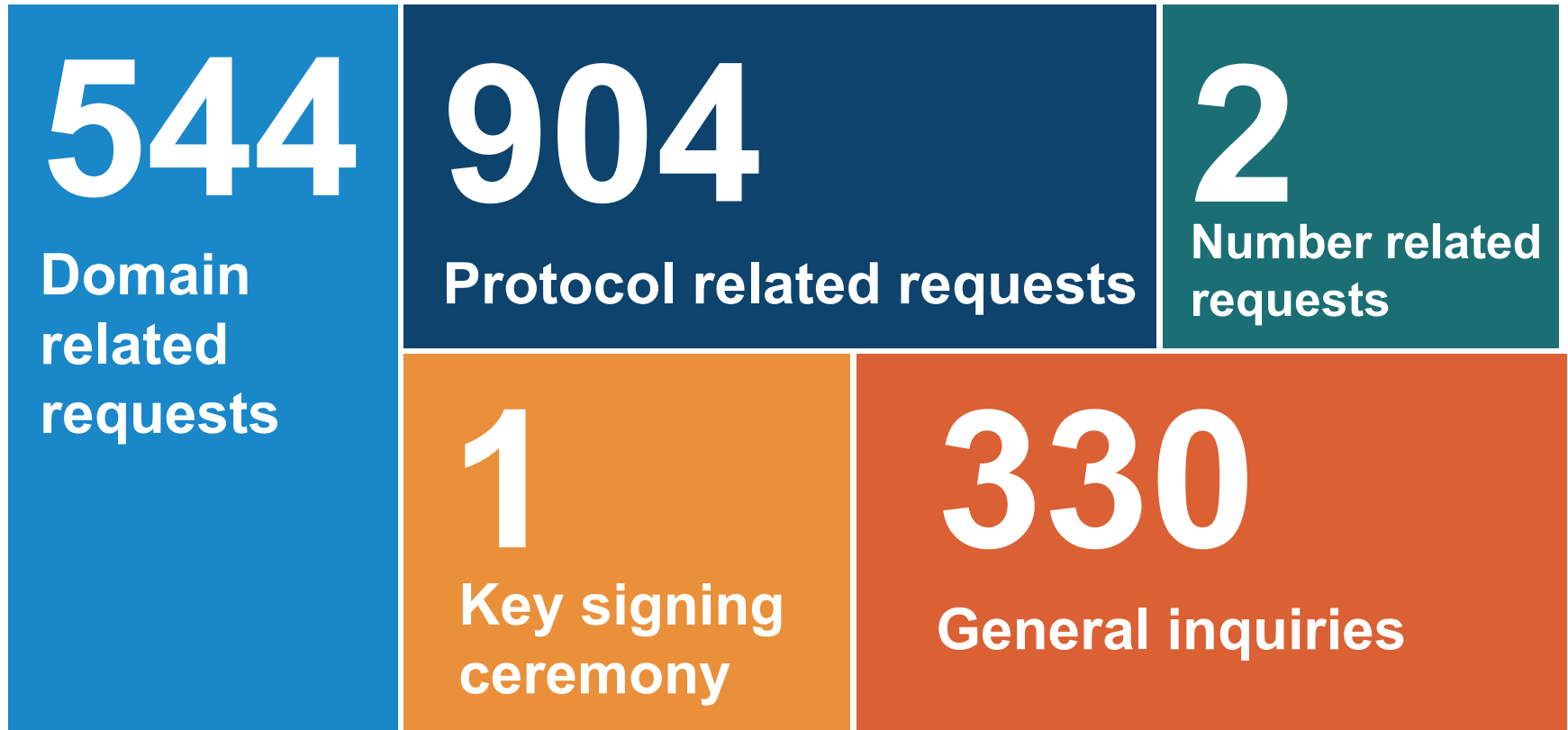

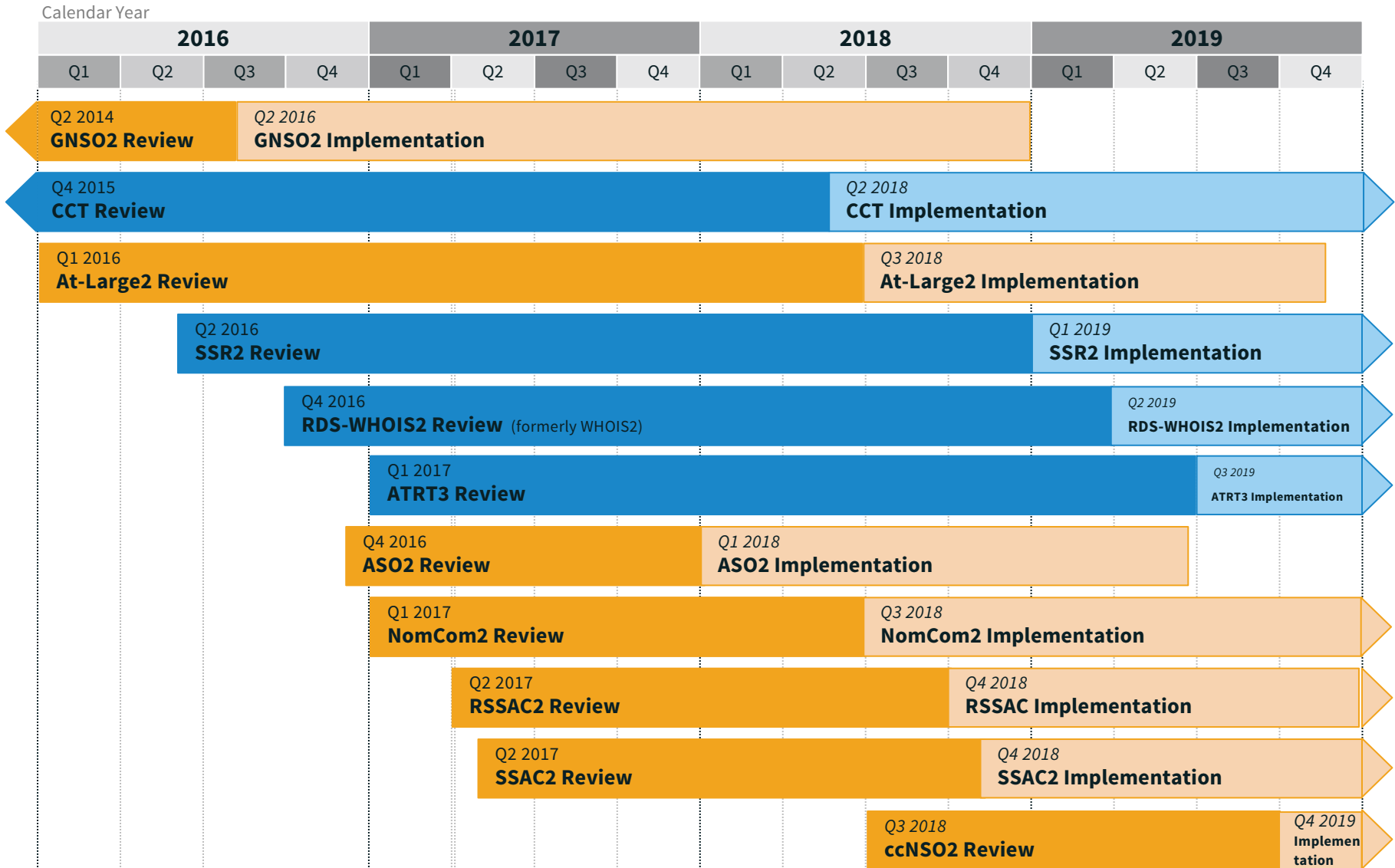

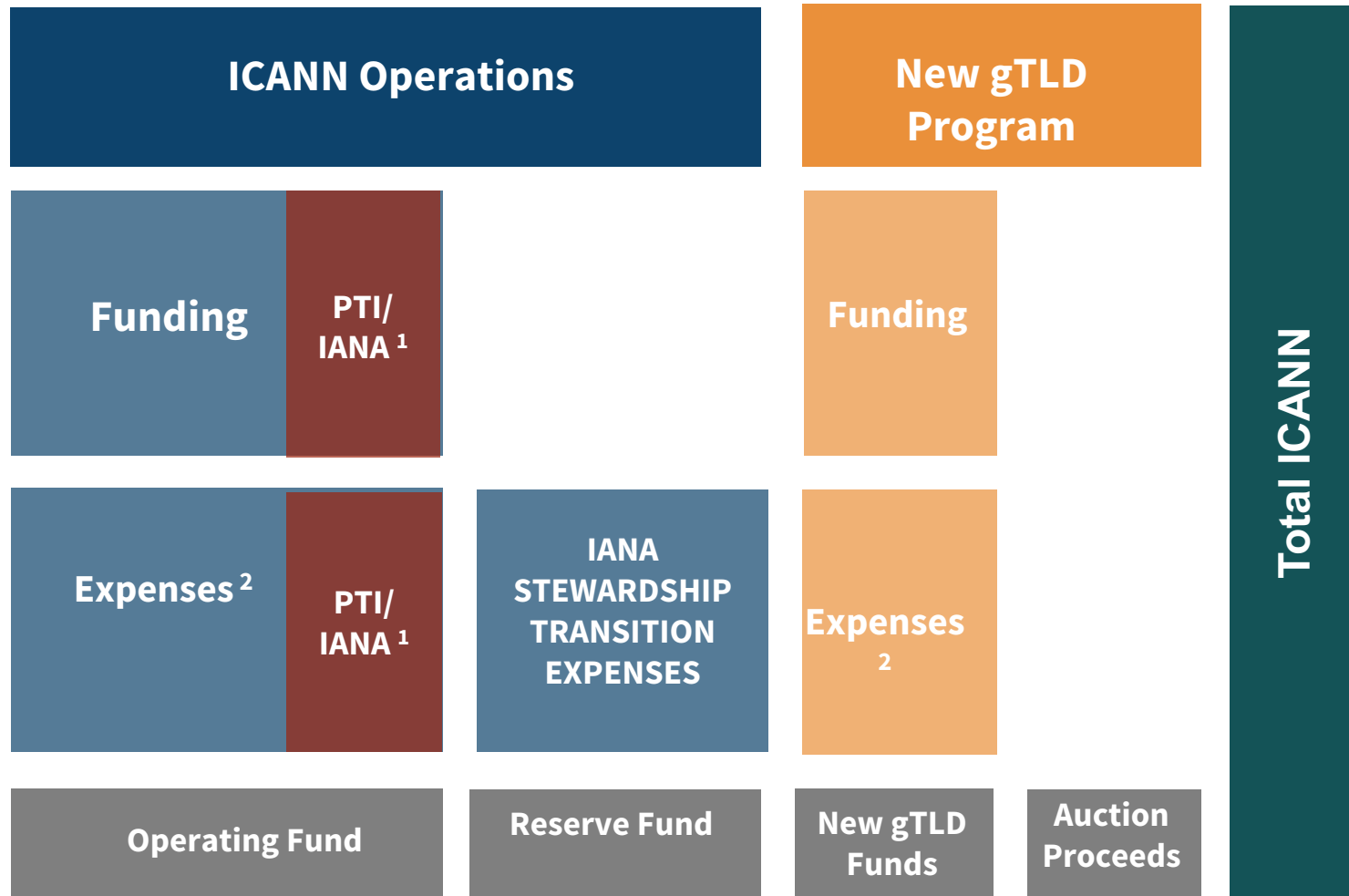

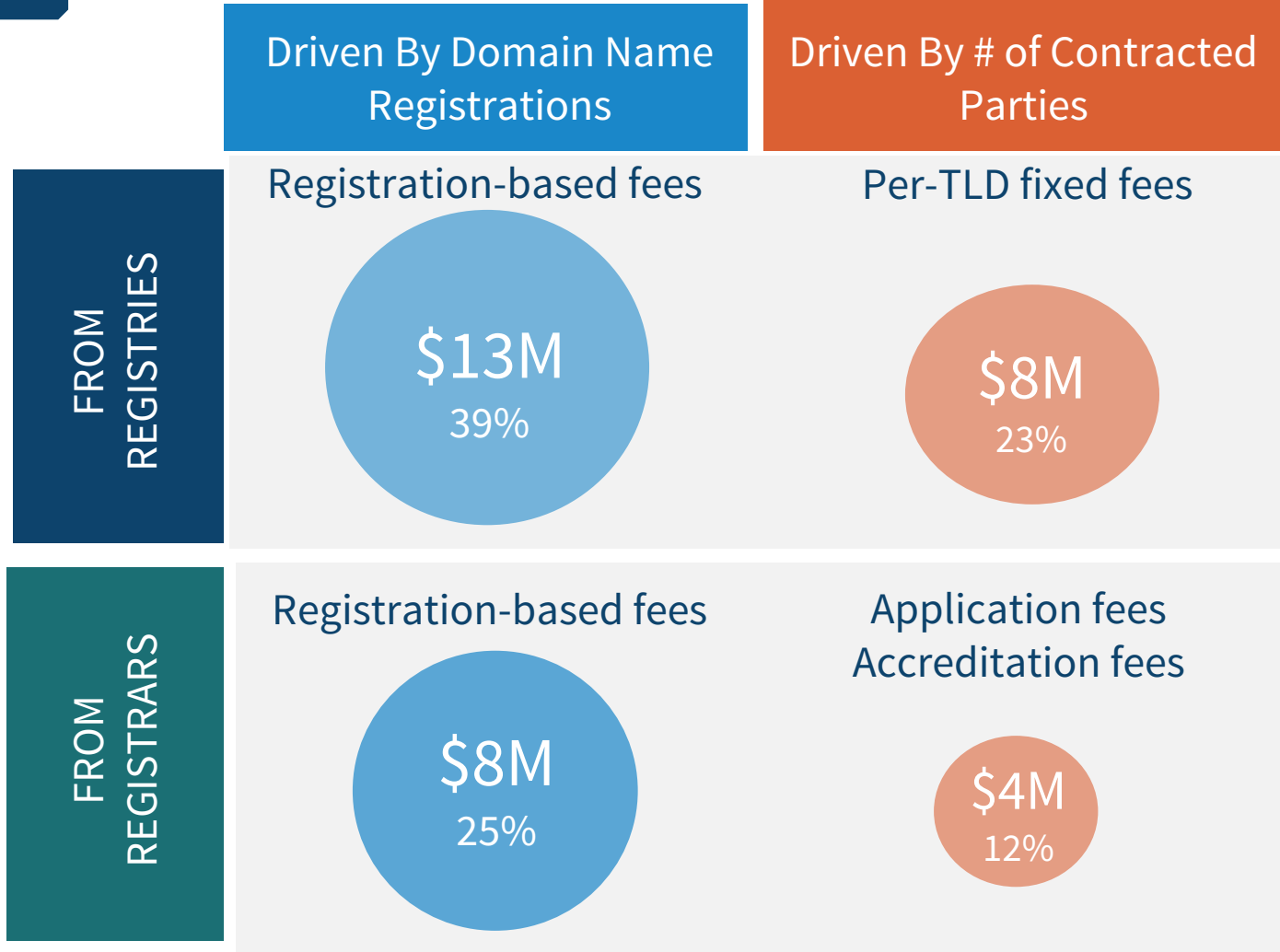

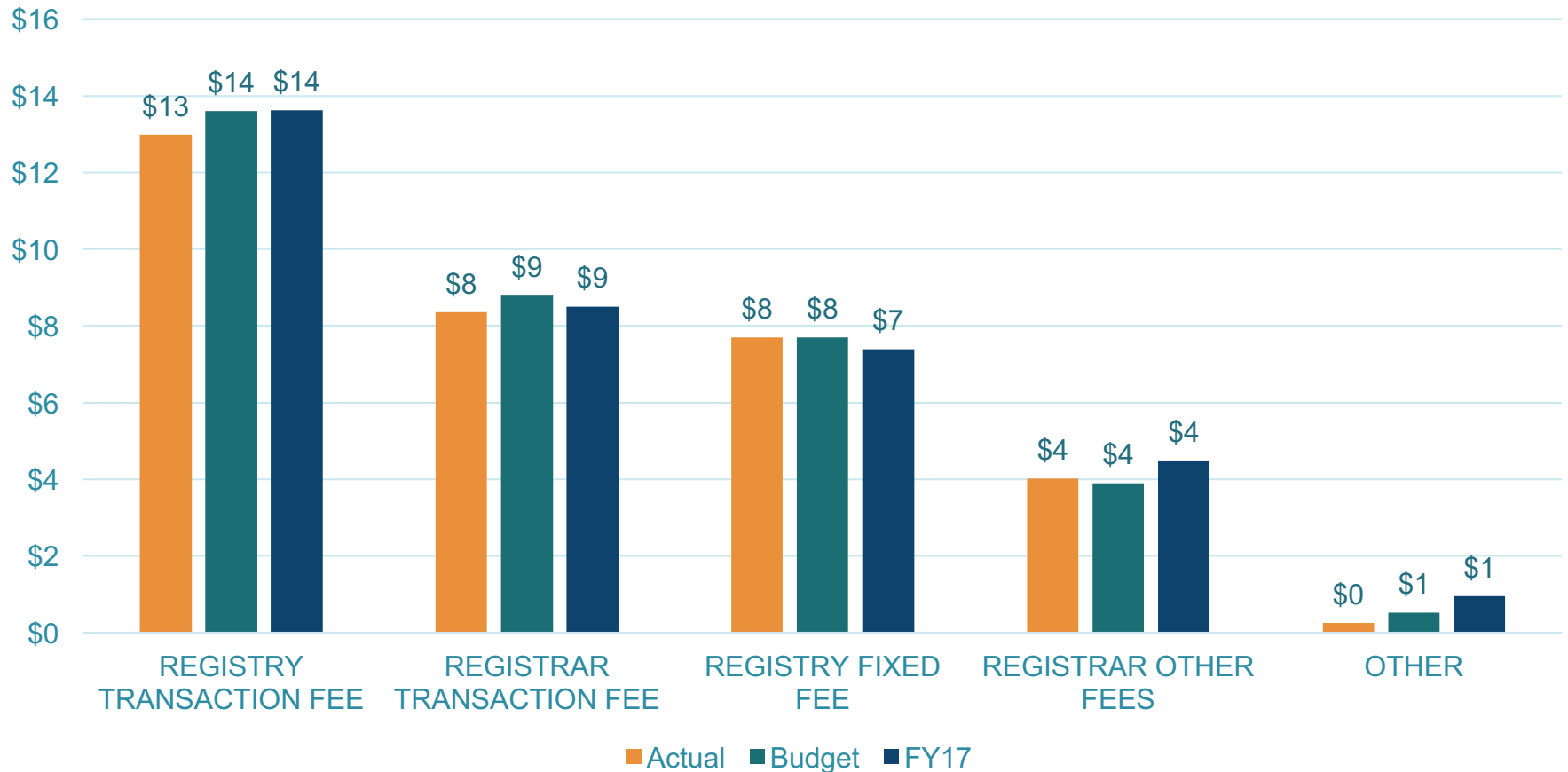

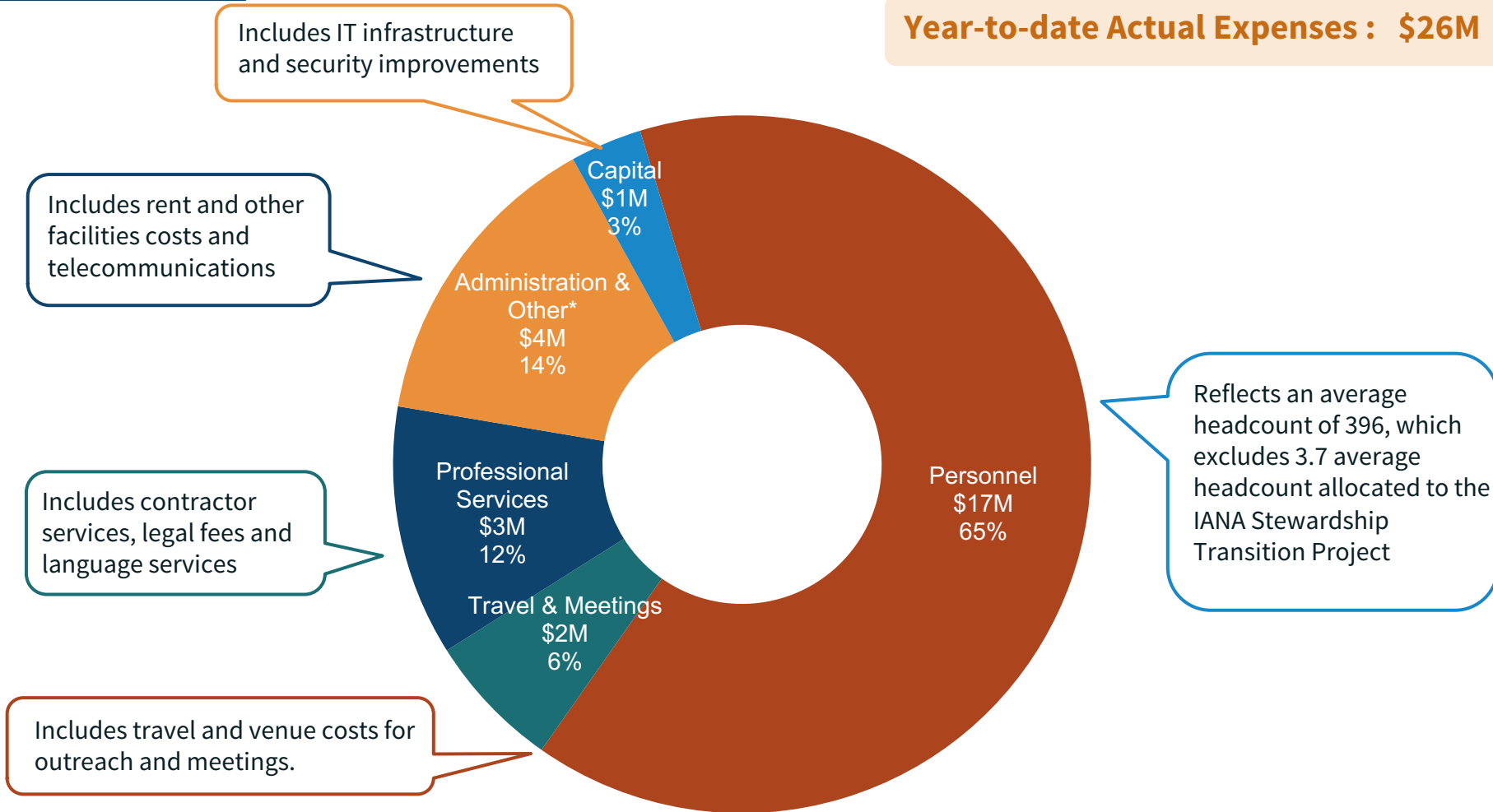

Year-to-date Actual Expenses : \$26M



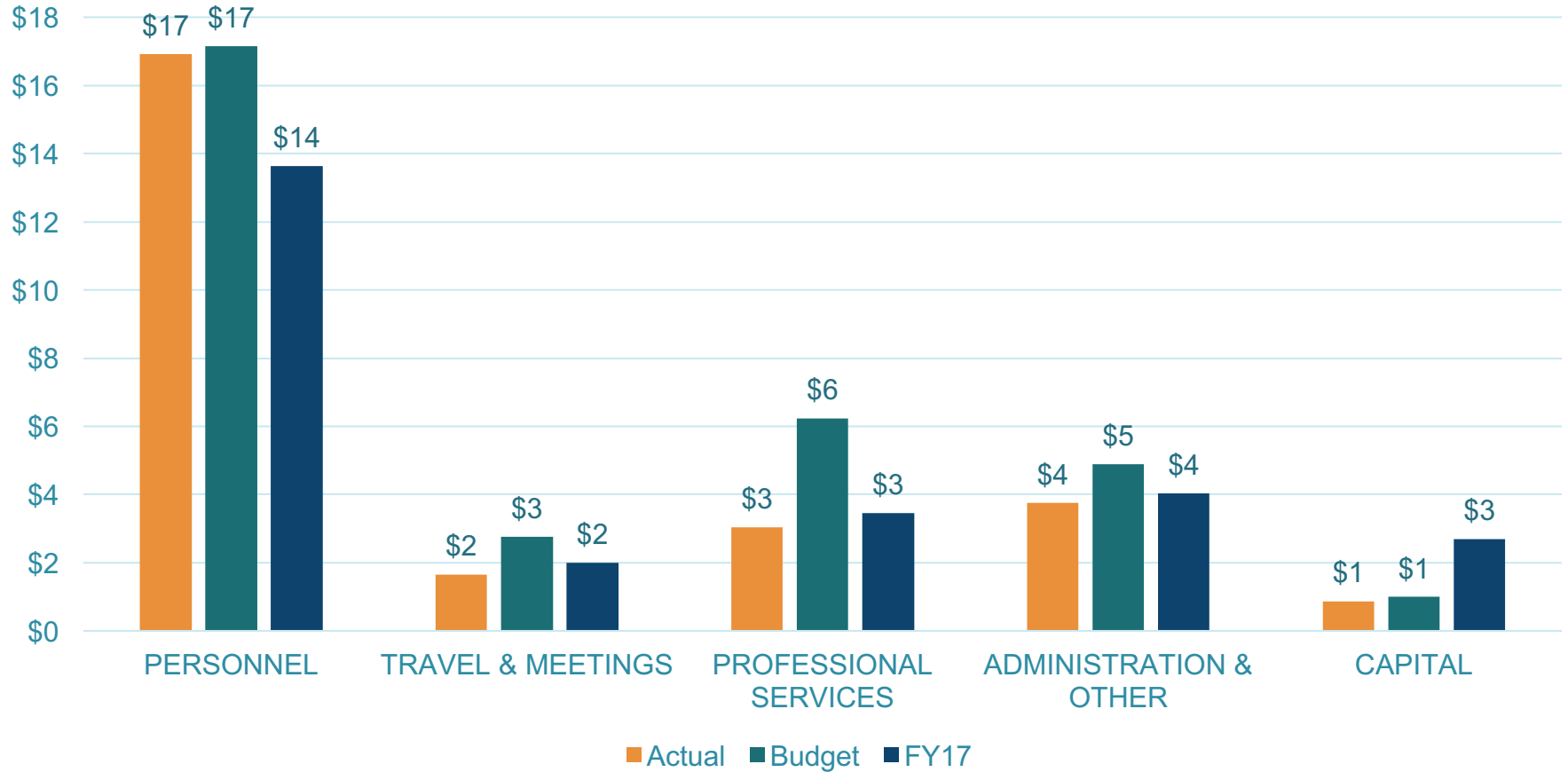

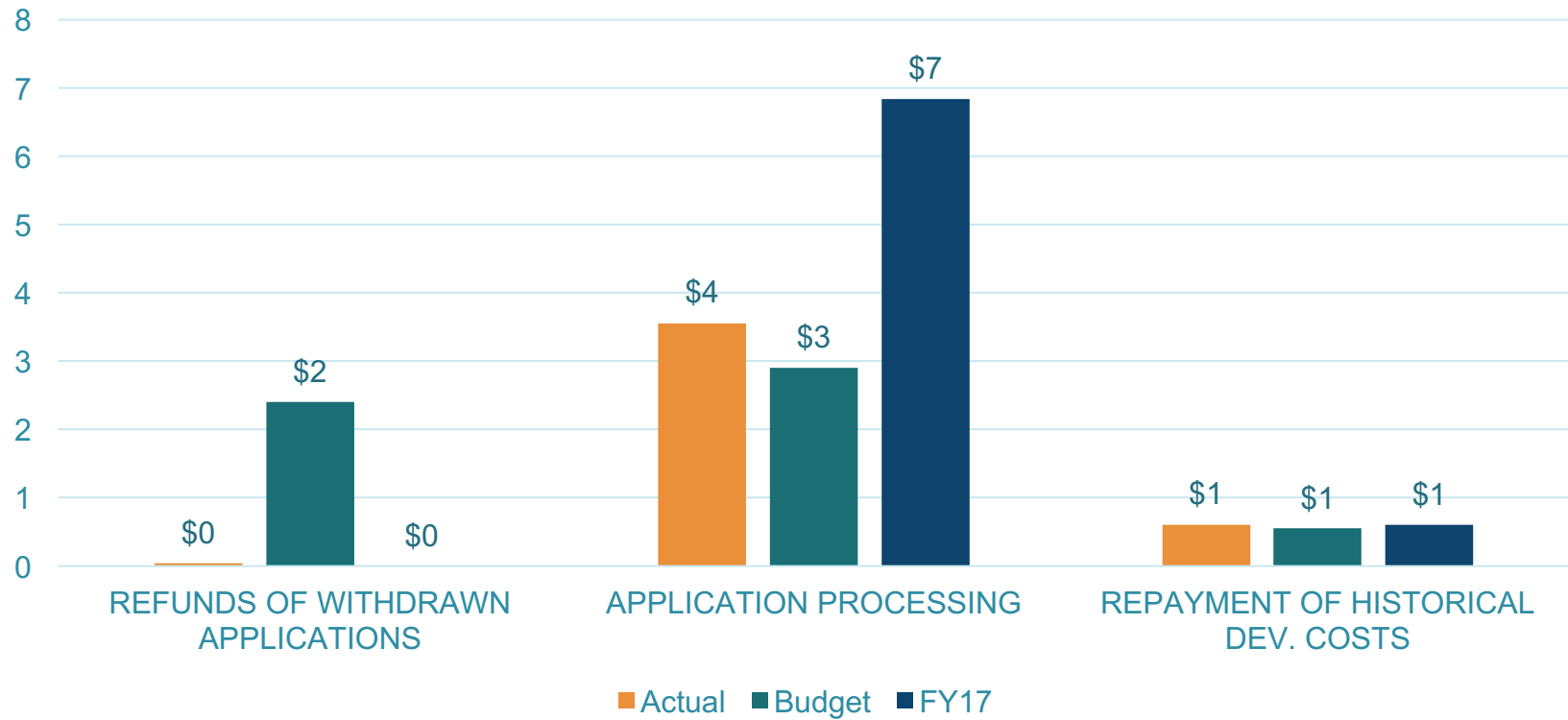


FY18 Q1 (July - Sep 2017) New gTLD Program Expenses vs Budget & FY18

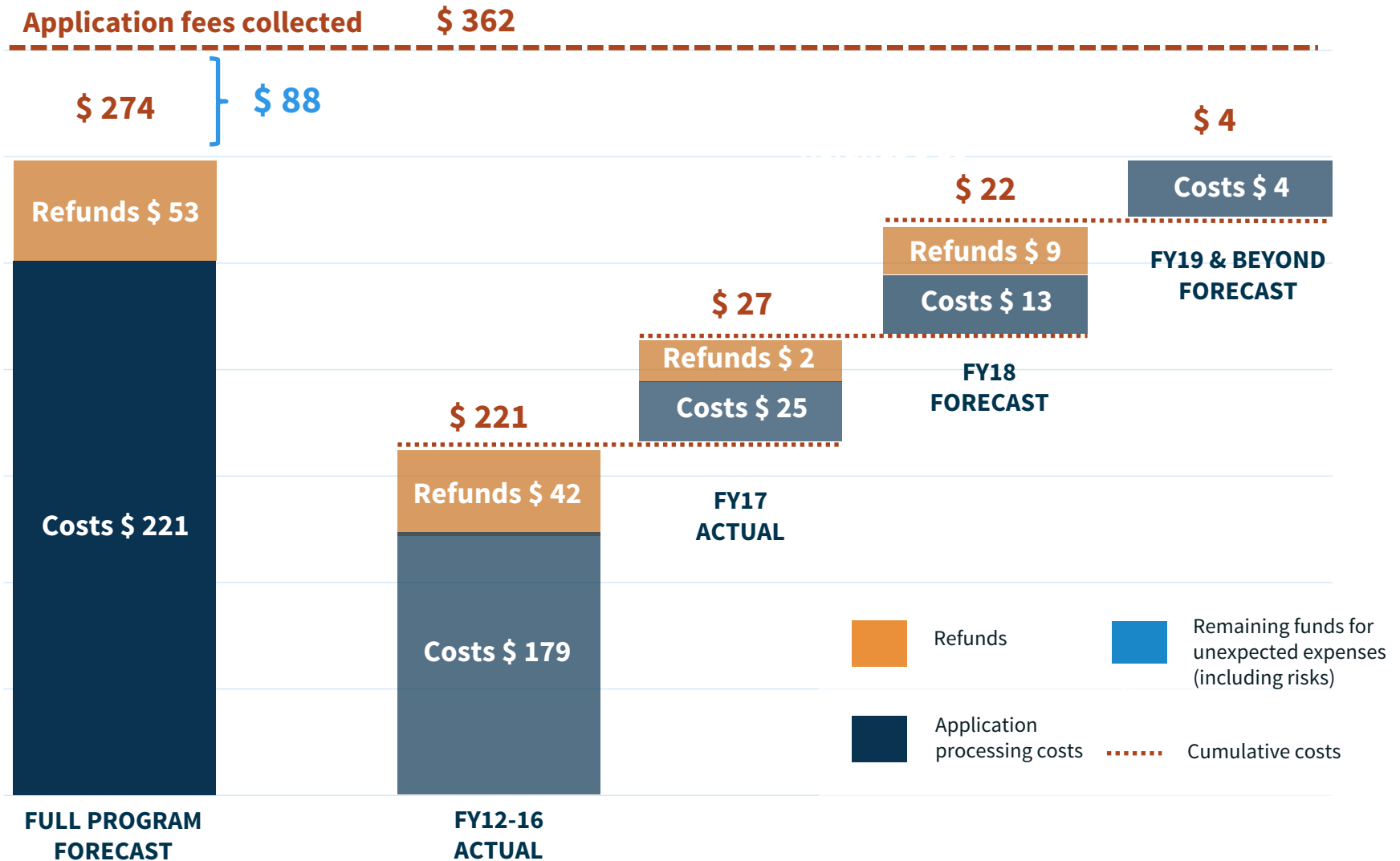
